



## ARTICLE III ELECTRICAL CODE

### SECTION 103-138

### PERMITS.

#### (e) PERMIT FEES

- (1) Permit fees shall be based upon the physical value of the work to be done as determined by the Fire Department – Division of Fire Prevention and Building Safety on the basis of current costs in the amount established by resolution.

Up to \$800	\$28.00
801 to 2,000	\$44.00
2,001 to 3,000	\$80.00
3,001 to 4,000	\$96.00
4,001 to 5,000	\$112.00

8,001 to 9,000	\$160.00
9,001 to 10,000	\$176.00

- (2) Additional permit fees for **fire alarm system components** are required as established by resolution.



## APPLY FOR INSTALLATION / MODIFICATION / REPLACEMENT OF A FIRE ALARM SYSTEM

**STEP 1:** Determine if your building requires a fire alarm permit application.

**YES.** A permit is required for the installation of new fire alarm systems, adding additional smoke or heat detectors to an existing system or is replacing an existing fire alarm system or fire alarm panel. (Replacement of an existing fire alarm system shall require the entire building's fire alarm system to be upgraded to current code compliance.) Proceed to STEP 2

**NO.** A permit is not required if adding additional notification devices.

**STEP 2:** Plans conditionally approved by the State of Wisconsin or a fire alarm plan reviewer approved by the City of La Crosse Fire Department are accepted. Buildings regulated by Health and Family Services (HFS) will require State approval. The La Crosse Fire Department will conditionally approve plans on the local level in addition to those requiring State approval. The La Crosse Fire Department has the right not to approve plans at the local level.

All plans must include:

- Scope of work
- All property information (i.e. business name, address, installer contact and phone number)
- Graphic information (i.e. scale, points of compass)
- Wiring diagrams
- All standards that the system was designed to
- NICET certification documentation
- Battery calculations
- Make and Model of smoke or heat detectors installed
- Make and Model of pull stations installed

Other items to note regarding fire alarm systems:

Status panel. Fire alarm systems shall display at a panel the device(s) activating the fire alarm system and capable of indicating the status of all specific components connected to the system. As determined by the Fire Department, additional notification and/or initiation appliances or devices may be required due to size, occupancy hazards, building construction and/or occupancy use.

**STEP 3:** Obtain a signed contract with a minimum of one year monitoring services by an alarm monitoring company.

**STEP 4:** Complete the required application.

STEP 5: Calculate the Permit/Acceptance Test Fee.

STEP 6: Send or drop off the completed application, two sets of hard copy alarm system plans, one set of electronic plans (PDF) format, a copy of the monitoring contract and the Permit/Acceptance Test fee to:

STEP 7: Installation of a fire alarm system may begin after issuance of permit. Verbal notification for starting installation by the Fire Prevention Bureau may be granted before the permit is processed. Installation of a fire alarm system prior to issuance of a permit or verbal authorization will result in Double Fees. Work shall be completed by certified personnel.

STEP 8: The installer of the fire alarm system shall provide a minimum of two business days' notice to the Fire Prevention Bureau prior to the performance of any inspection or test to the system.

STEP 9: The Fire Prevention Bureau shall conduct an acceptance test of the system according to NFPA 72 standards. A NFPA 72 Fire Alarm Completion Record shall be required at this time. Monitoring shall be required at time of acceptance. The system will be "live" at the completion of final testing.

Responsibilities of Fire Alarm System Owners after system acceptance:

All buildings or portions of buildings containing fire alarm system, whether required by this Code nor not, shall be maintained in good working order and tested annually by a qualified fire alarm company as required by NFPA 72. Records of this testing shall be located by the fire alarm control panel and be made available to the Fire Department upon request.

All fire alarm systems whether required by this Code or not, shall undergo annual testing by a qualified contractor. Records of the testing shall be located by the fire alarm control panel. The testing shall involve the activation of either a smoke detector or pull station which shall cause the building's fire alarm horn and/or strobe units to activate.

The occupant or owner of a building shall notify the Fire Chief or Fire Department immediately when the building's fire alarm system is rendered out of service for any reason. If the system is out of service for more than four consecutive hours in a 24-hour period, the building shall be evacuated or an approved fire watch shall be provided as specified in the current printed version of NFPA 101 (Life Safety Code).

## NOTE

**Contractor shall provide the Fire Inspector a minimum of two business days' notice prior to the performance of any inspection or test to the system. Alarm monitoring shall be live at final inspection. If a re-inspection is required the Contractor shall pay a fee of \$75.00, payable to the La Crosse Fire Department prior to the next inspection.**
