Do you live and / or work in the City?

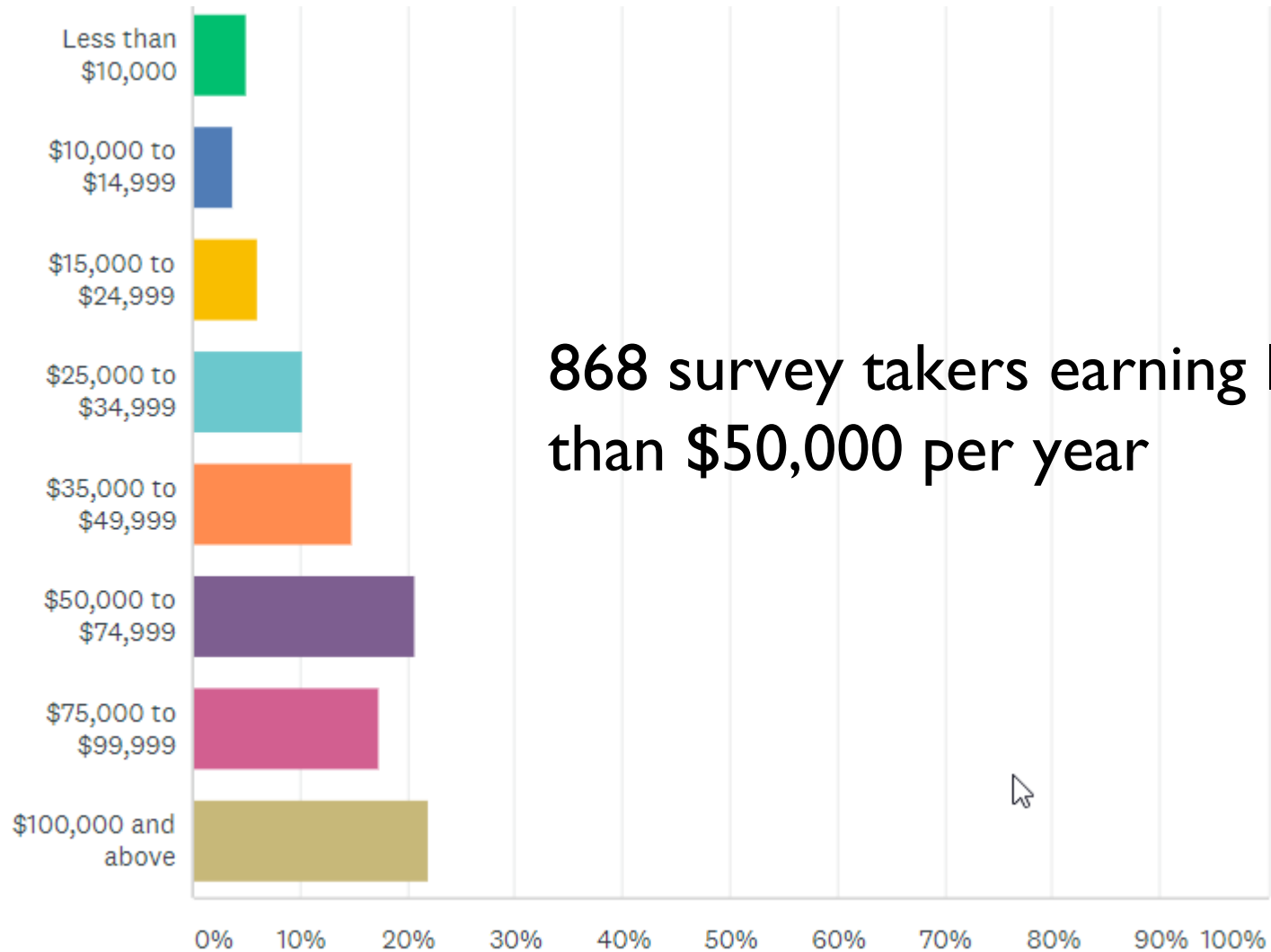
- 1828 Live in the City

Good representation of all neighborhoods

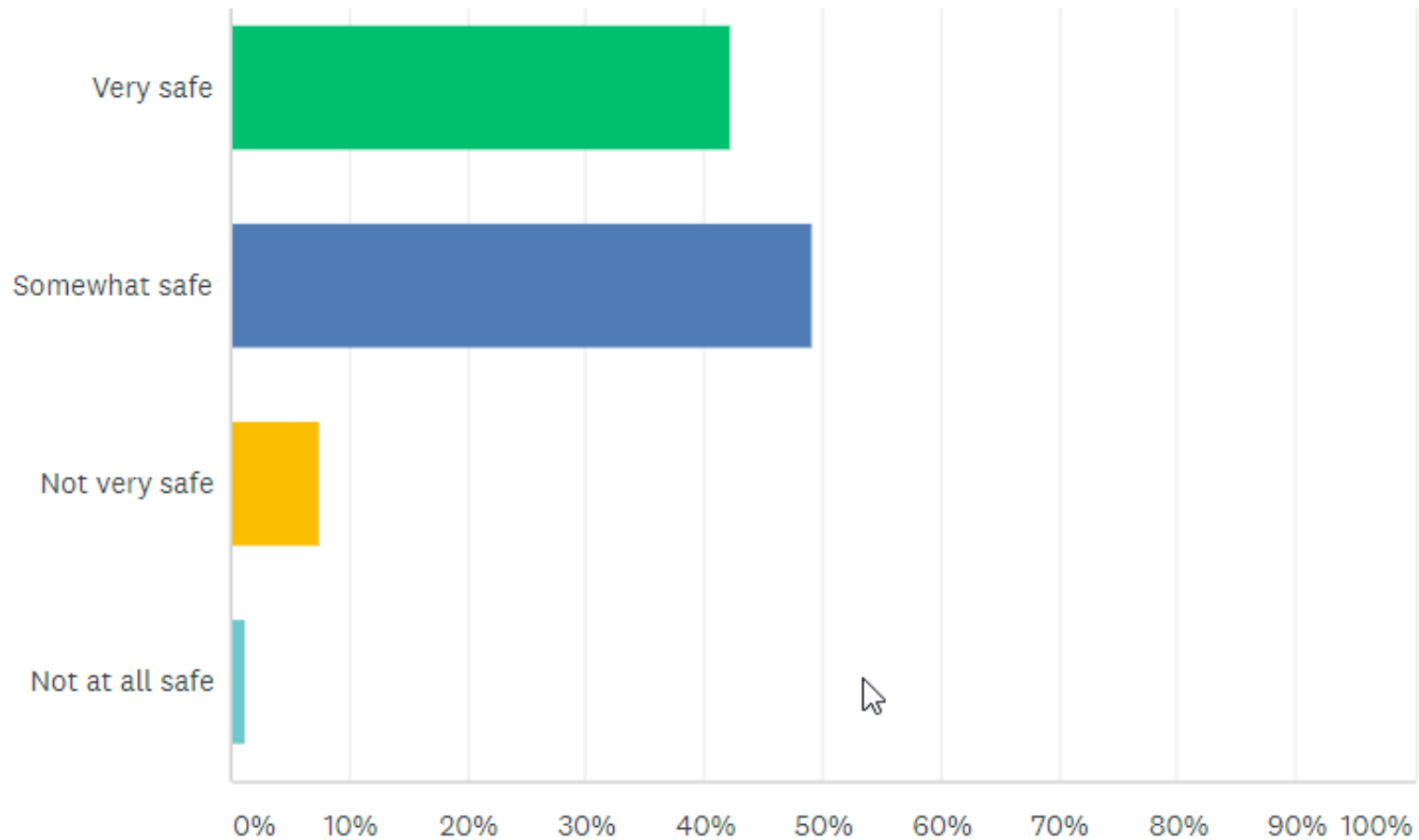

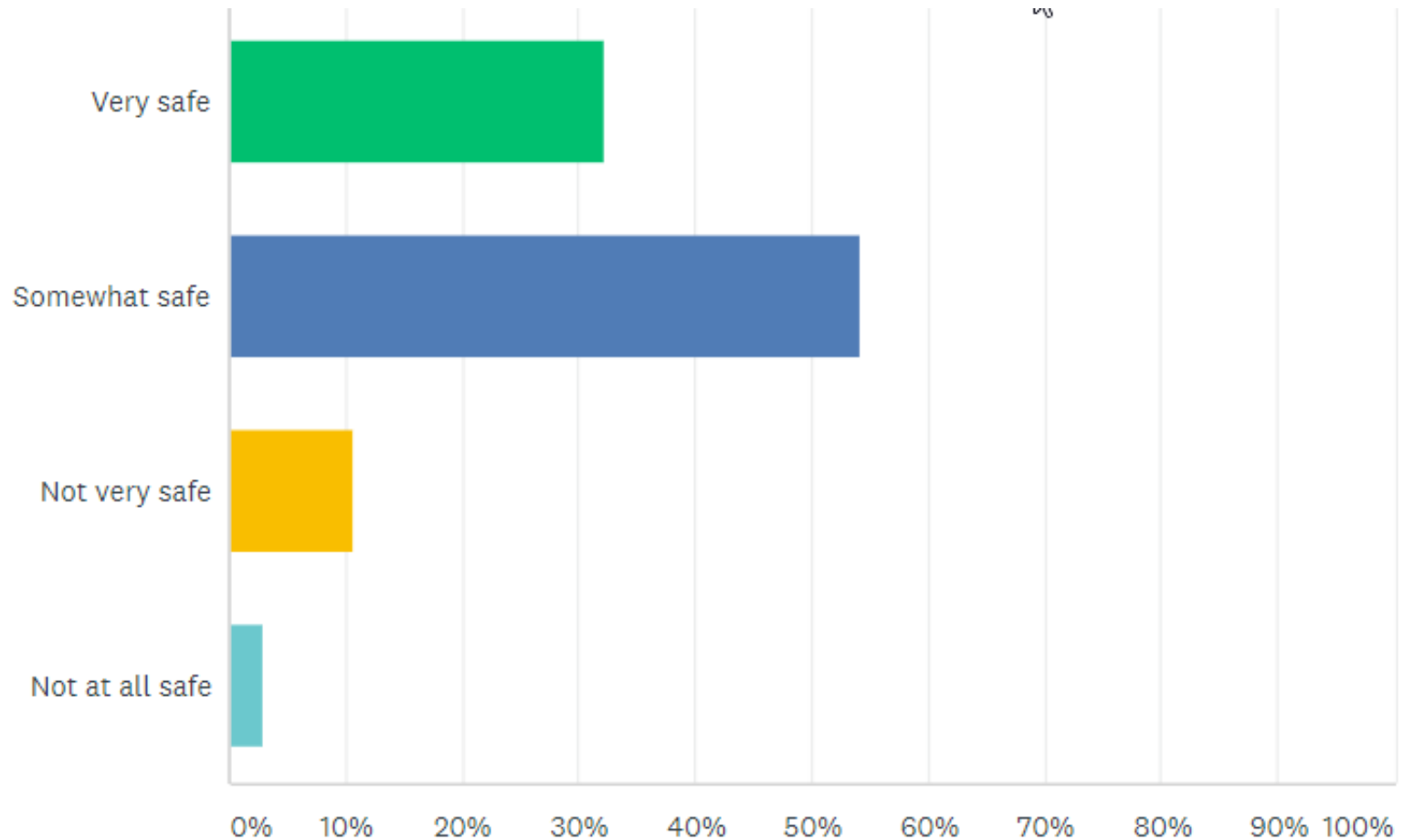


How safe do you feel? (overall)



- 2019 42% feel very safe in their neighborhood
 - 2014 37% feel very safe
- (5% increase in safety perception)

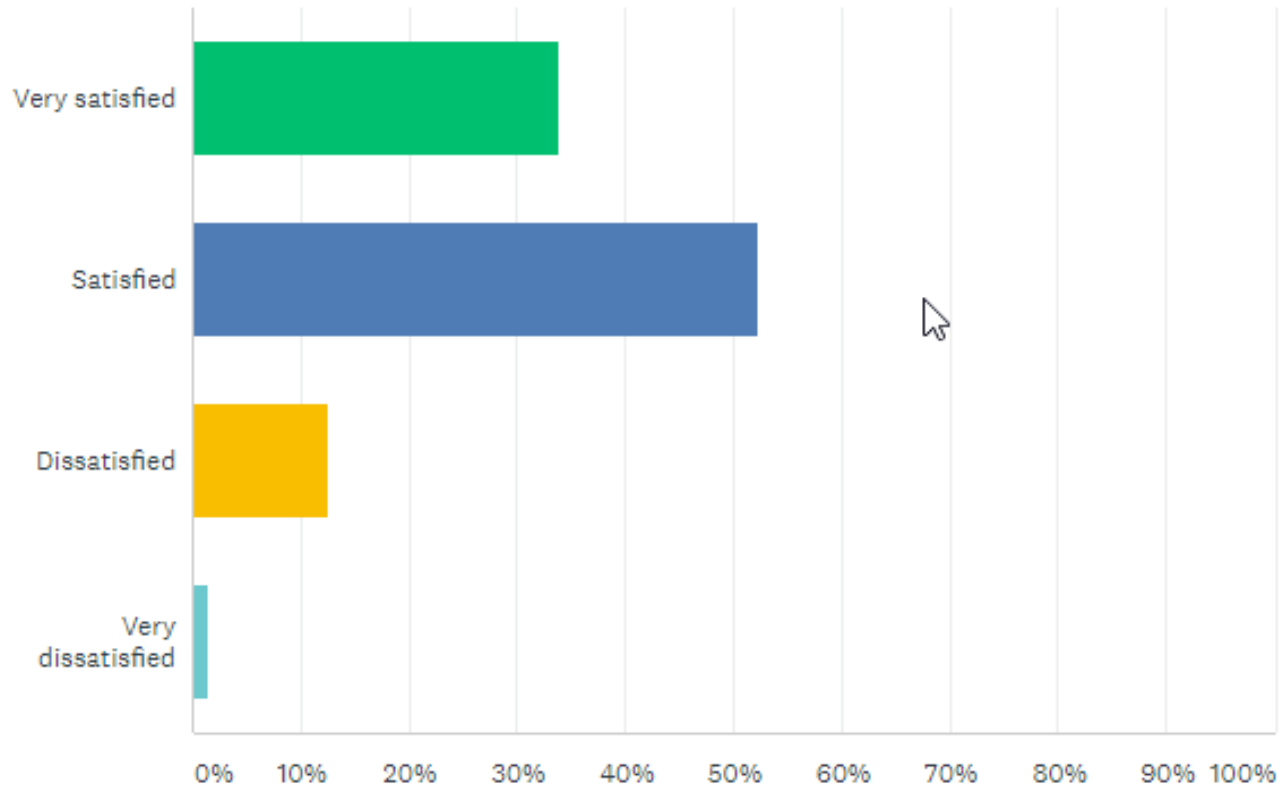
How safe do you feel? (low income, renters)



- 2019 32% feel very safe
 - 2014 27% felt very safe
- (5% increase in personal perception of safety)

How satisfied do you feel? (overall)

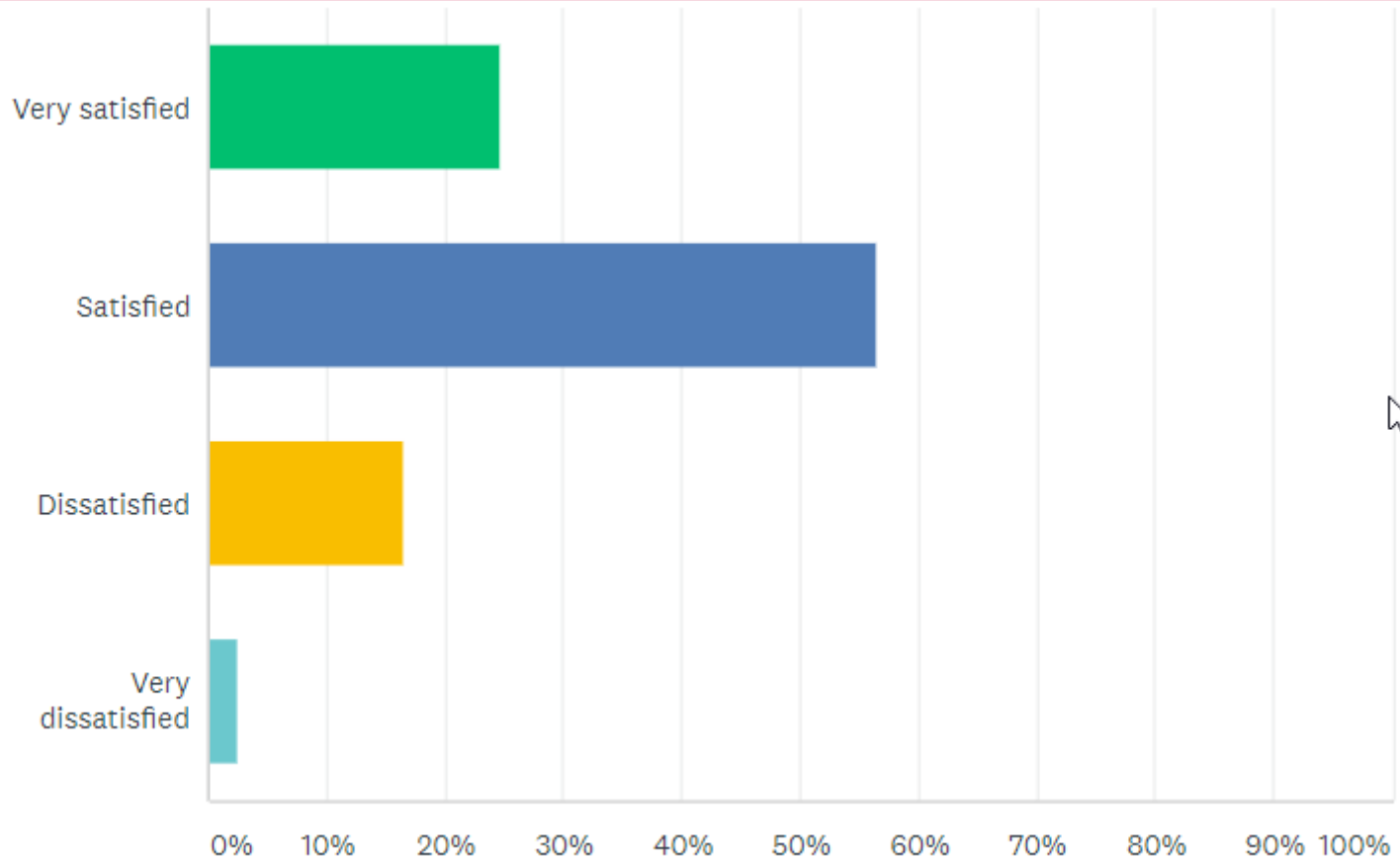
Answered: 1,658 Skipped: 84



- 2019 34% feel very satisfied
- 2014 21% feel very satisfied

(13% increase in satisfaction with neighborhoods)

- 2019 24.7% feel very satisfied, 56% satisfied
- 2014 14% feel very satisfied, 29% satisfied

(10% increase in satisfaction with neighborhoods)

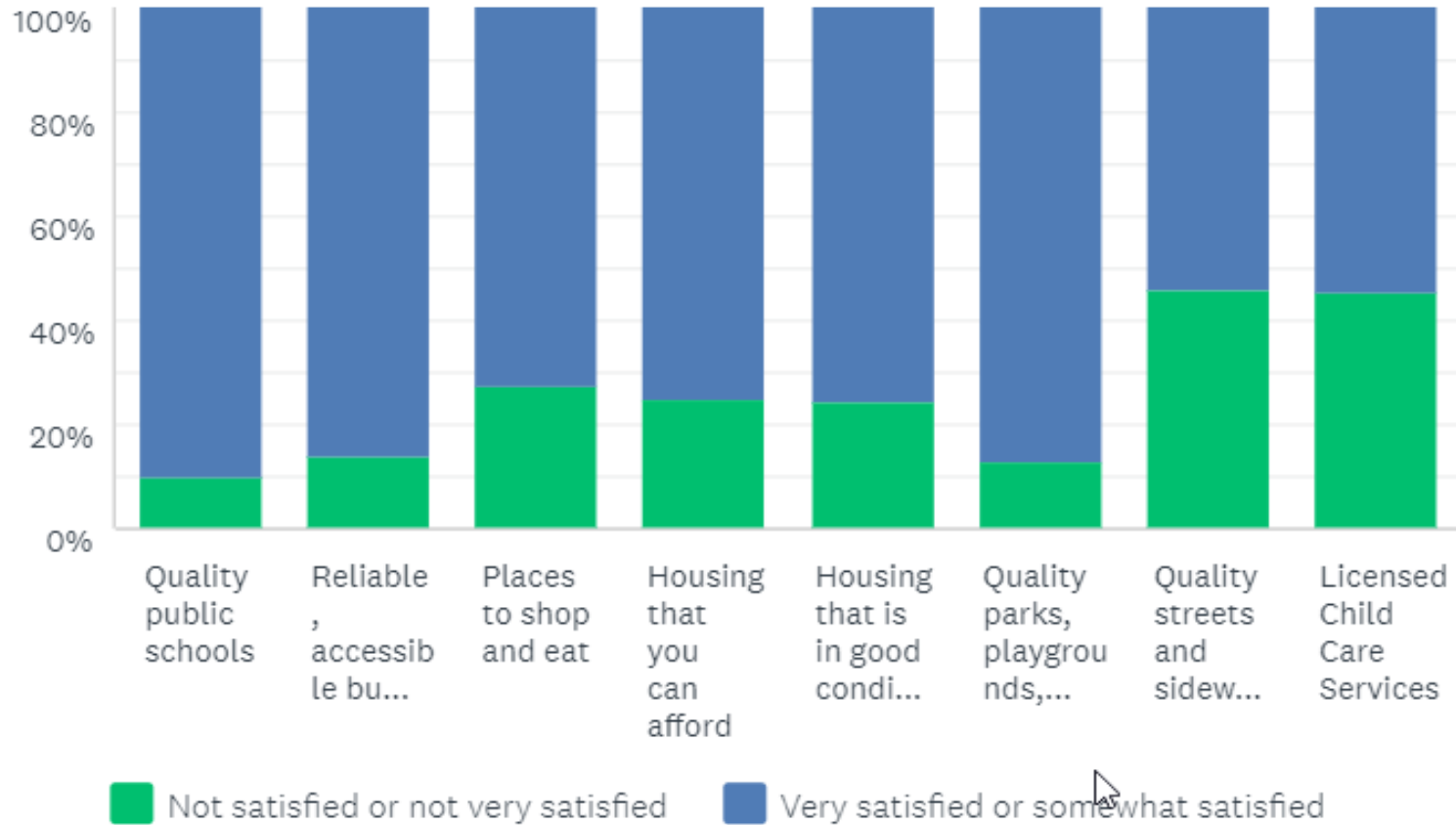

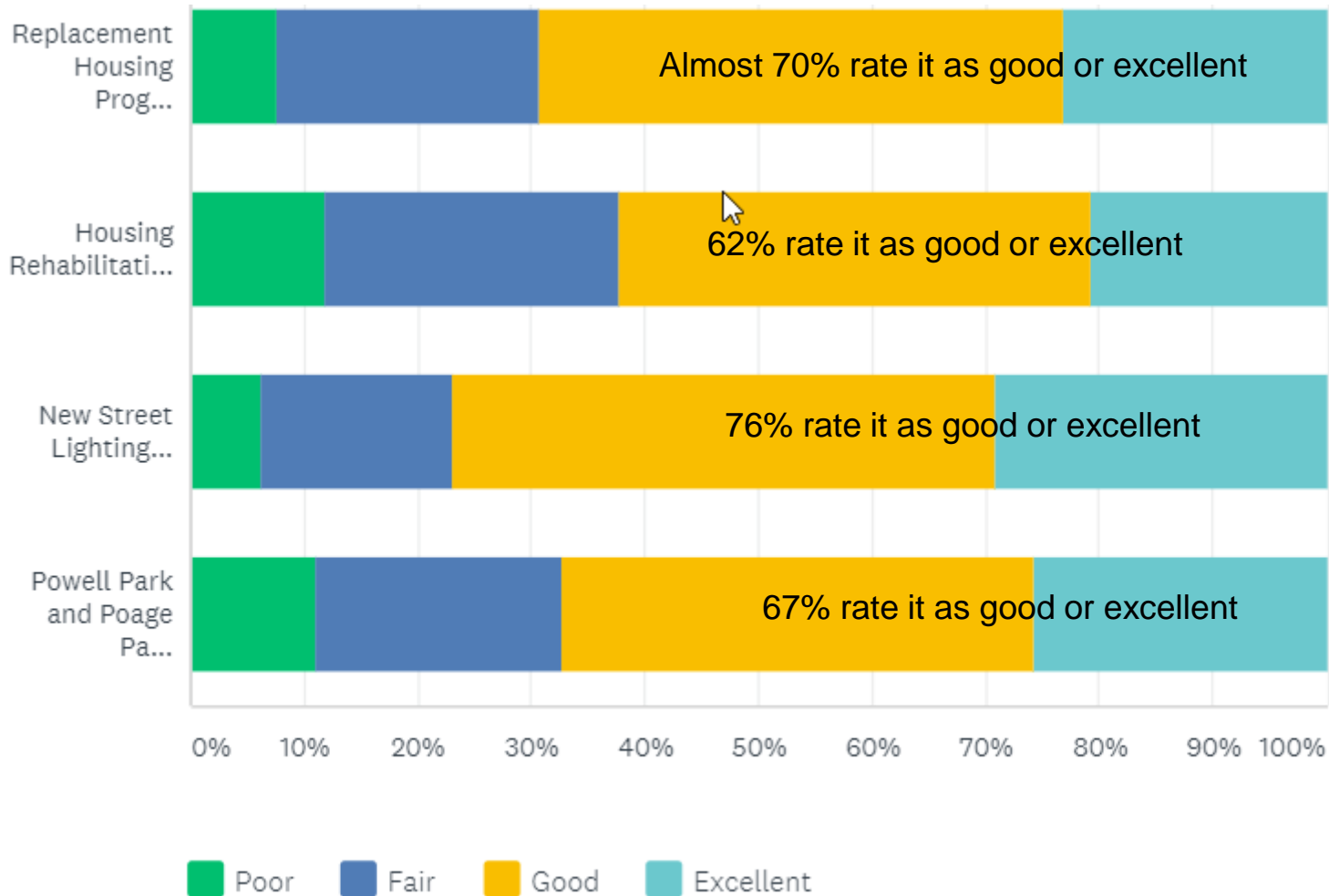
- Street Lighting (100)

How satisfied are you with your access to the following resources?

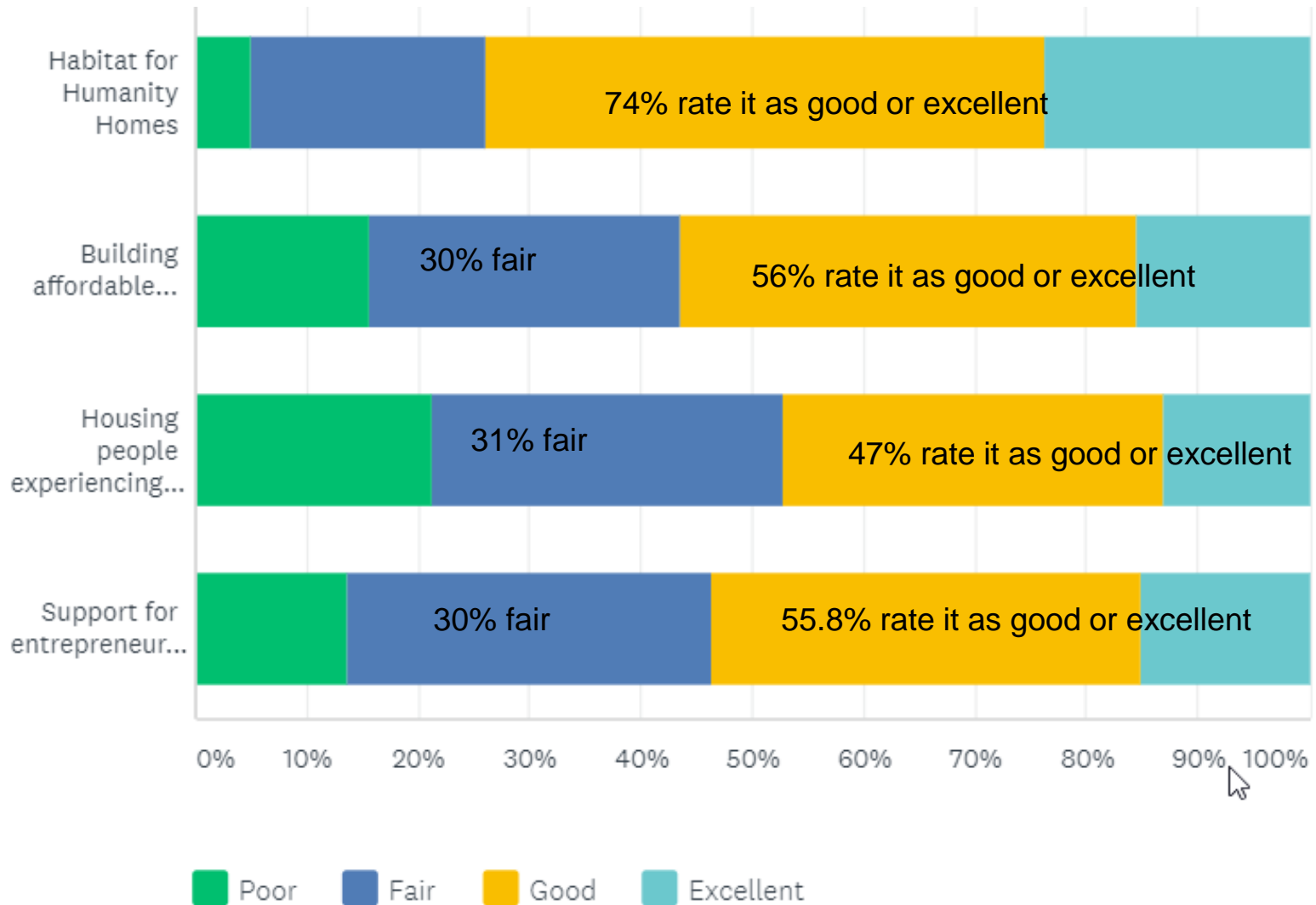


People are the happiest with their access to quality parks and playgrounds. Also public schools. Least satisfied with access to licensed child care services and the quality of the streets. For LMI, 42% not satisfied with finding housing they could afford and 36% not satisfied with housing quality

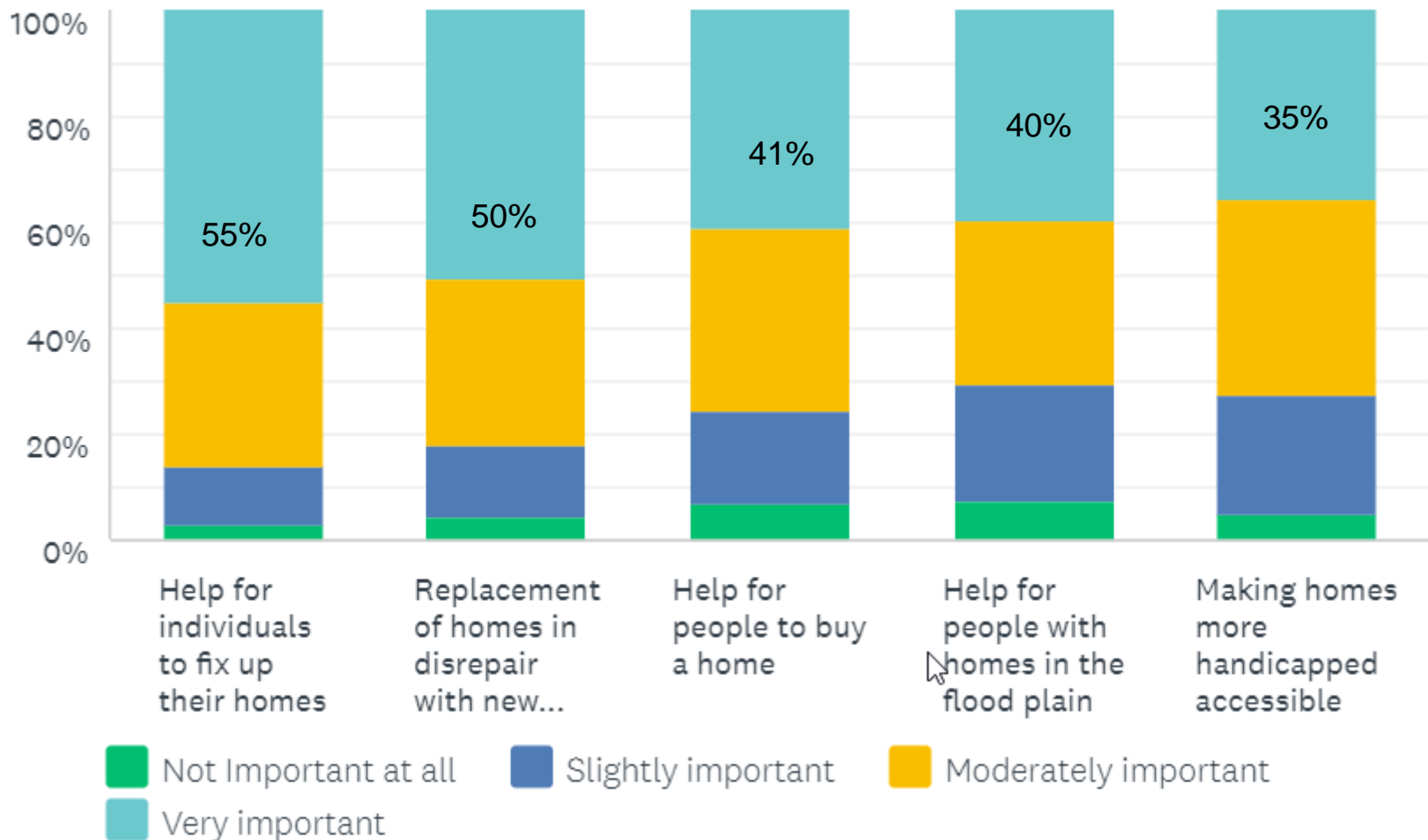
Rate the quality and effectiveness of City programs.



Rate the quality and effectiveness of programs funded by the City.

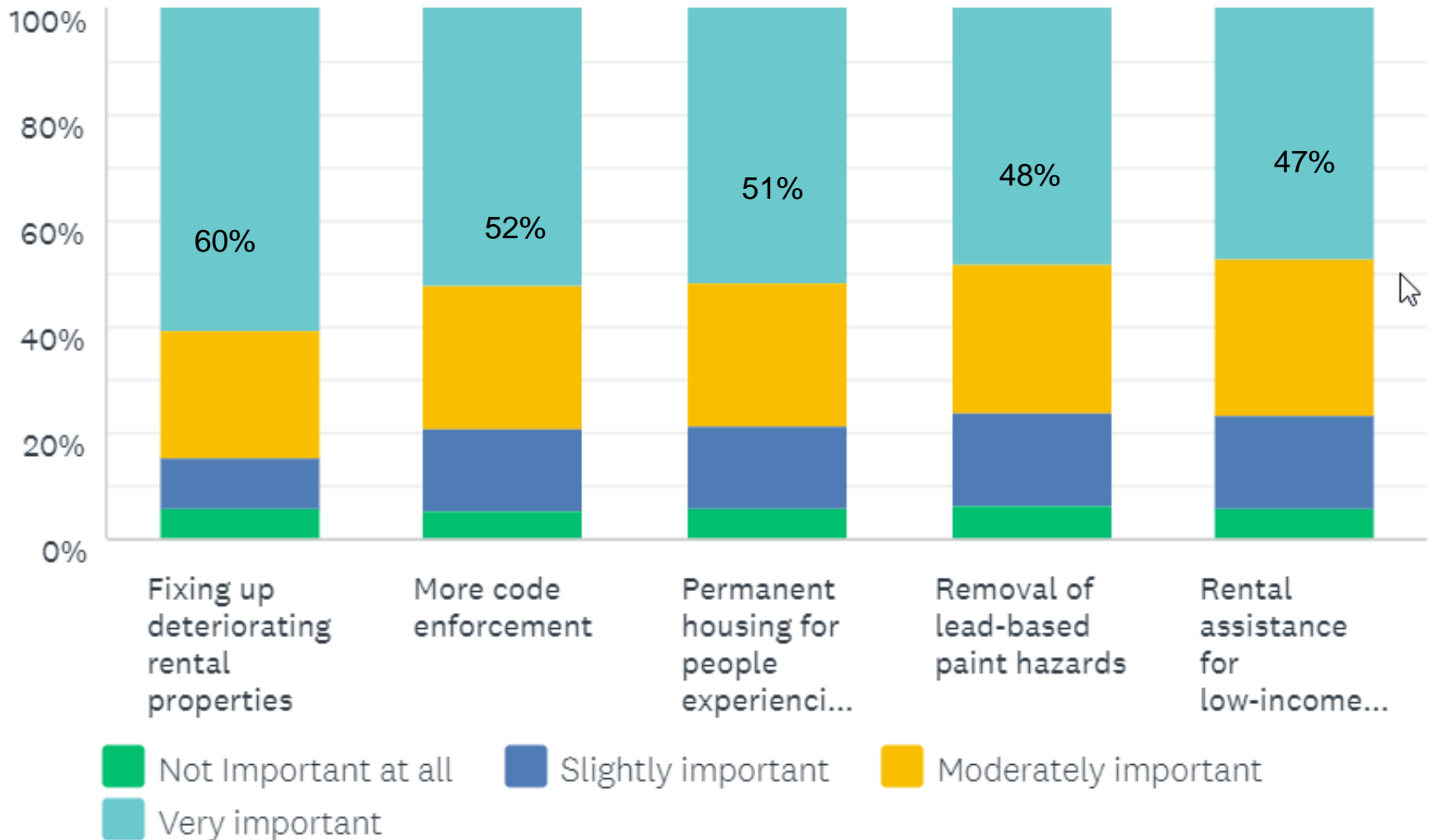


Programs that meet City's homeownership needs

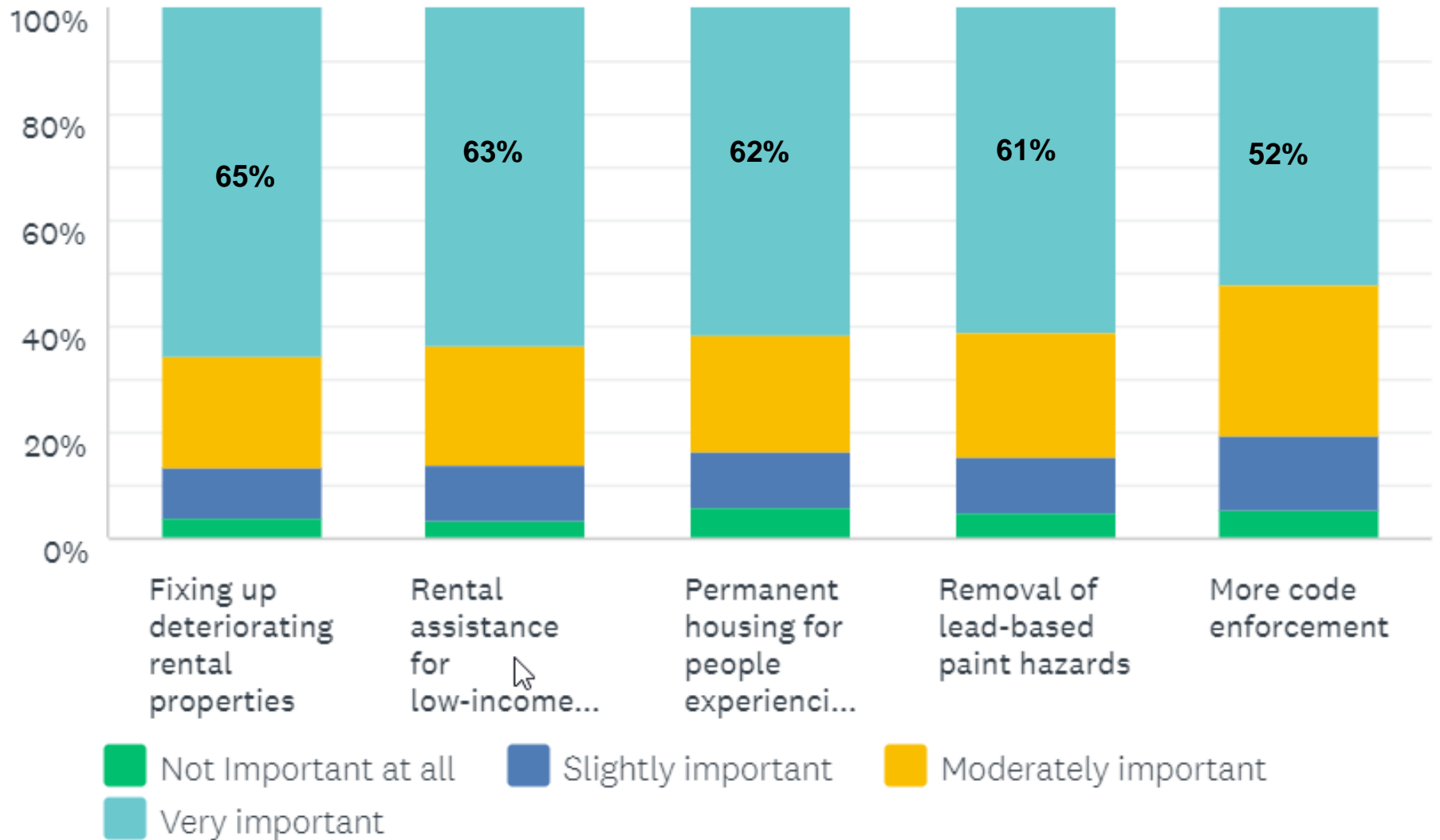


Majority of respondents think these programs are very important or moderately important. Helping individuals fix up their home was ranked number one, followed closely by rehabbing homes. This is the same as 5-years ago. Low-Income responders thought it was more important to help someone buy a home rather than tear it down and replace.

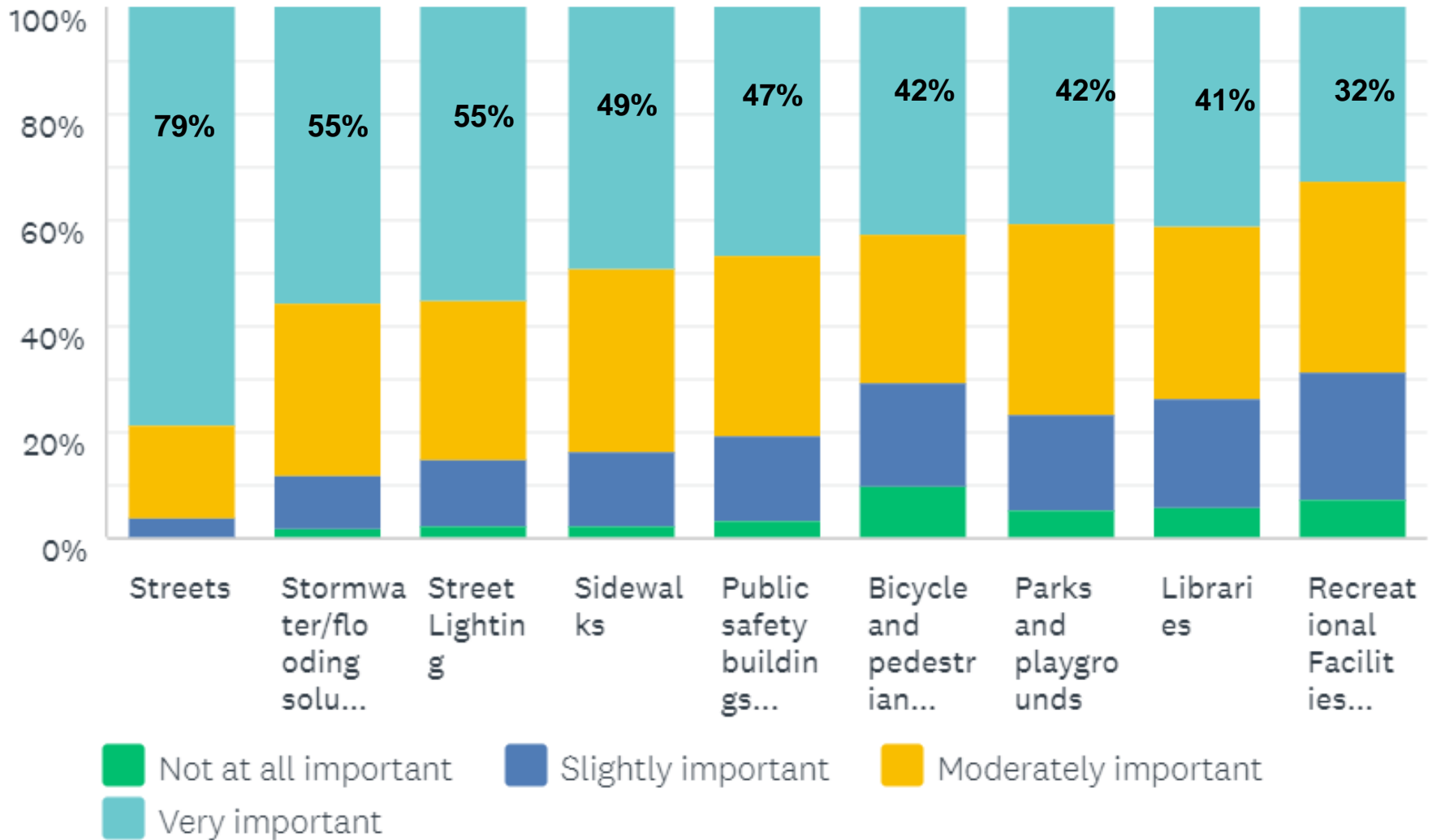
Programs that meet City's rental needs



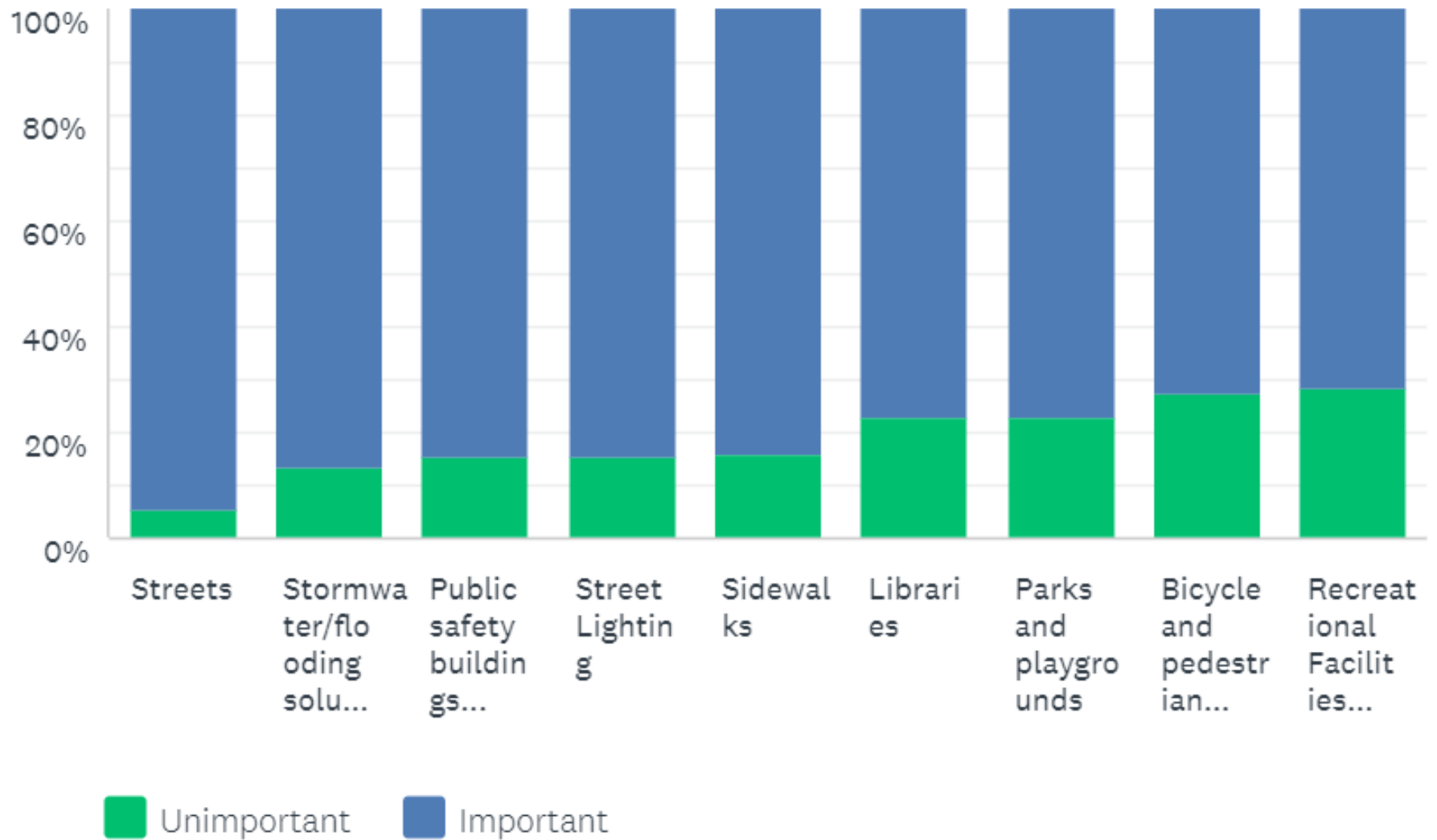

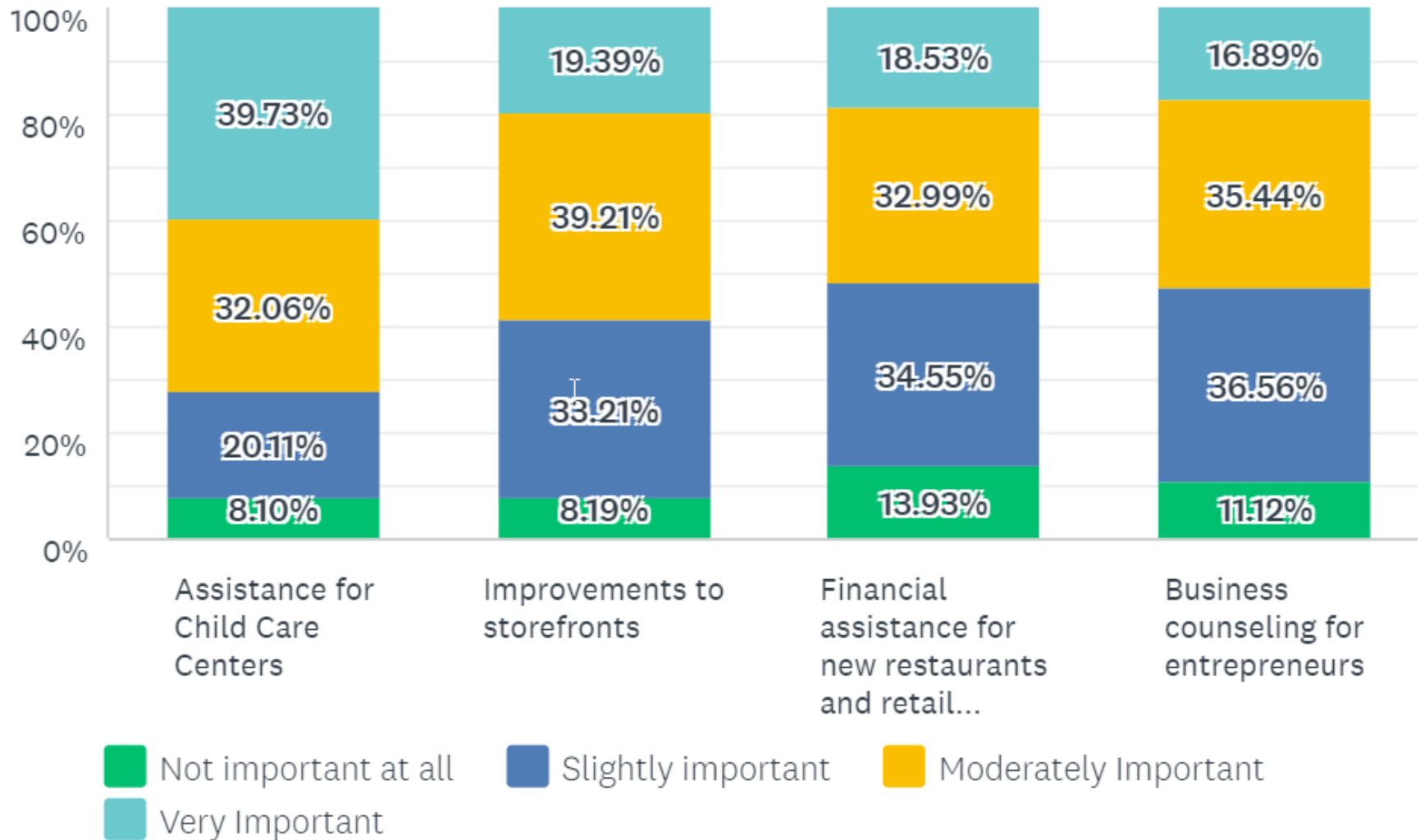
How important are the following capital improvements?

How important are these Economic Development programs?

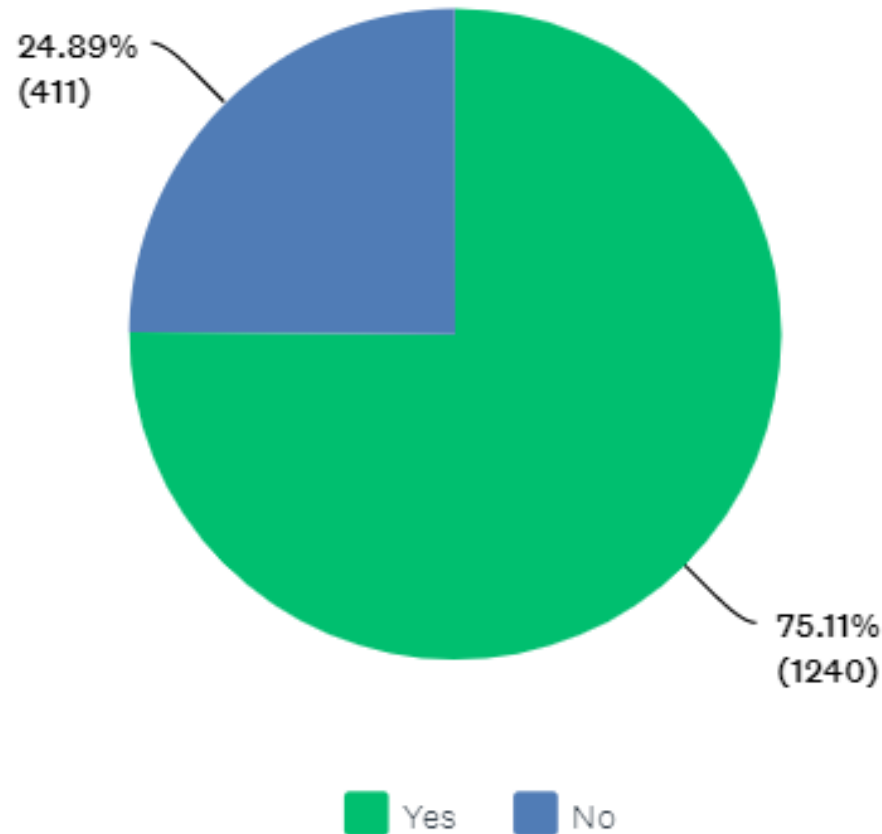
