- 1. The applicant shall be primarily liable for damages to person or property by reason of the granting of this street privilege permit.
- 2. Applicant waives any and all rights to contest in any way or manner the validity of Sec. 66.0425 of the Wisconsin Statutes.
- 3. Provision for a bond is hereby waived.
- 4. The applicant for a permit to encroach on the public right-of-way shall procure and maintain for the duration of the permit a minimum liability and contractual liability policy in the amount of \$100,000.00 each person, \$300,000.00 each accident for bodily injury and \$100,000.00 for property damage. A certificate of such insurance shall be filed with the City Engineering Department as part of the application. The insurance shall name the City, its officials, employees and agents as additional insureds. In addition, in order to keep the permits up to date, the street privilege permit program turned into an annual renewal process.
- 5. Applicant agrees that if he does not remove the sprinkler system within ten (10) days after receiving notice from the City to do so, the City is authorized to remove the same and applicant agrees to pay the City for all costs of such removal, waiving all rights to contest in any manner the validity of this section or the amount of compensation charged.
- 6. Applicant further agrees that the City shall not be liable to applicants for any damage applicant may receive by reason of the encroachment in public right-of-way as indicated on the attached drawing or should the same be damaged by the City if the City performs work or maintenance in the area of the street privilege permit.

- 7. Applicant further agrees that the obligations and conditions of this street privilege permit shall be binding upon all heirs, successors and assigns of applicants.
- 8. Applicant further agrees that the City shall not be responsible for any compensation to the applicant should the Street Privilege Permit be revoked, and applicant further waives any and all benefits under Federal or State Eminent Domain or Relocation laws.
