In the News:

- November 27th - January 1st, LCFD and other area fire departments participated in the "Keep the Wreath Green" fire prevention campaign. Additional details can be found on page 7.
- November 30th, LCFD responded within three minutes and 21 seconds to a **garage fire** at 231 Copeland Avenue at 3:36 pm. A total of 17 personnel and seven apparatus responded and were on location for approximately one hour. The building sustained moderate damage to the exterior and LCFD Investigators determined the cause to be the improper use of burning materials.
- December 2nd, LCFD responded within three minutes and 15 seconds to a **garage fire** at 609 Rose Street at 3:11 pm. On arrival, crews observed heavy smoke and fire coming the interior of the garage. LCFD was on location for approximately one and a half hours, with a total of 22 personnel and eight apparatus responding. The garage sustained significant fire and heavy smoke damage which was determined to be caused from a spark.
- December 9th, LCFD was dispatched for a **person who had fallen off their bike and was injured** on the Grandad Bluff hiking/biking trails at 2:53 pm. Crews responded to the base of Grandad Bluff by 29th Street South and Ebner Coulee Road. The injured person was located within 14 minutes of arrival and extricated around 4:30 pm.
- In December, the Wisconsin Policy Forum completed their study on Fire and EMS opportunities in the La Crosse County region. This study, titled "**Something in Common: Exploring Fire and EMS Service Sharing Opportunities in La Crosse County**", was funded through collaboration at the County's LAPC and with support from UWL. Multiple area Fire and EMS agencies participated, and this report is being submitted to the City of La Crosse Common Council on the February council agenda. 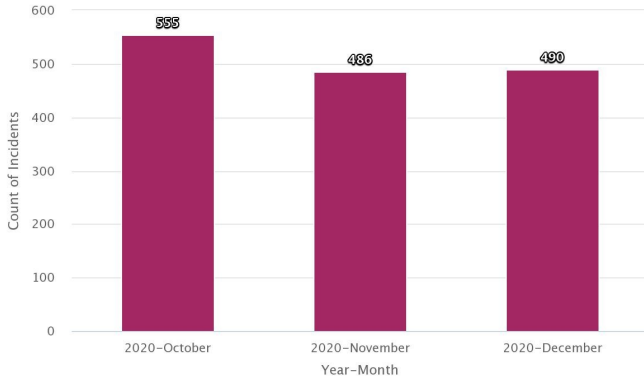

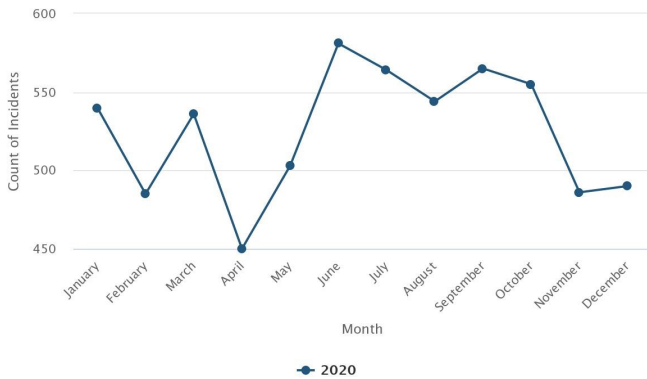
Incidents by Month



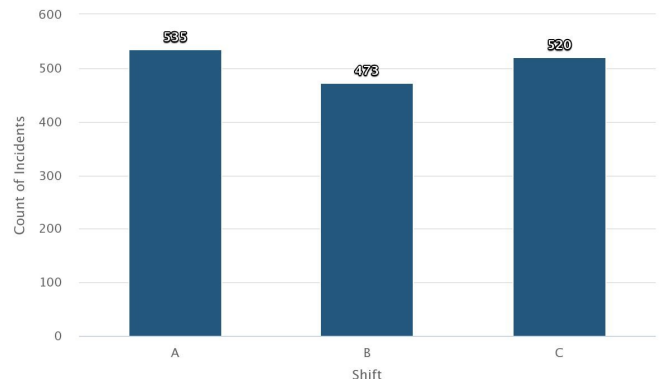

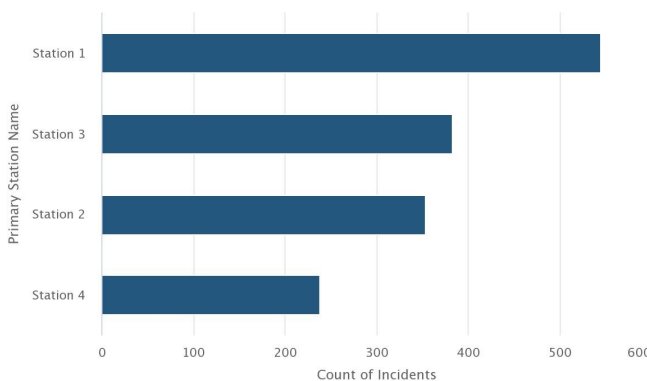
Fire Call Volume by Month - Year over Year



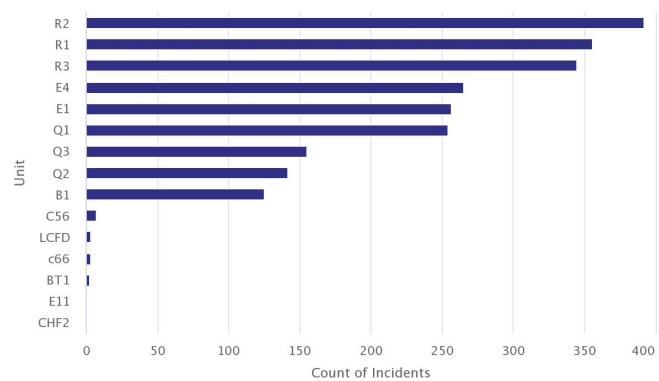
Incidents by Shift

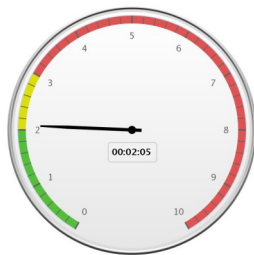

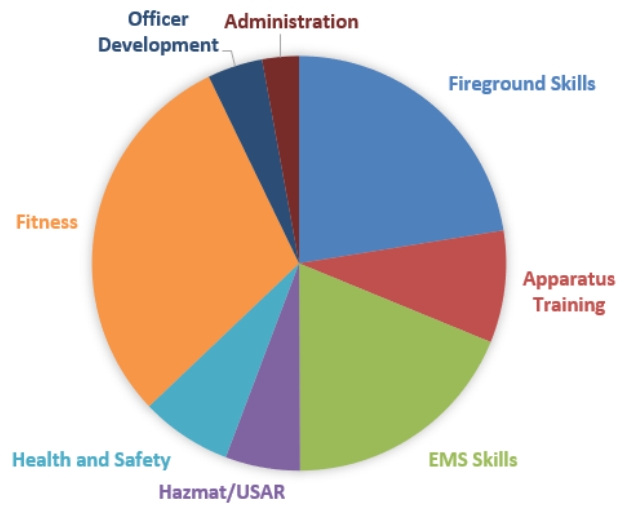

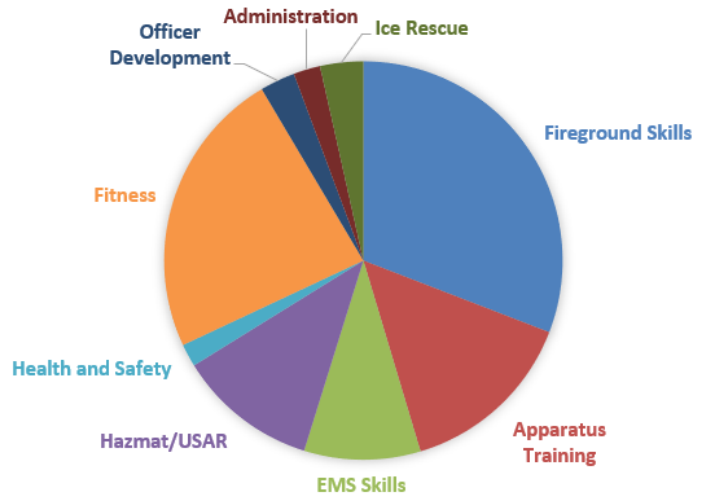

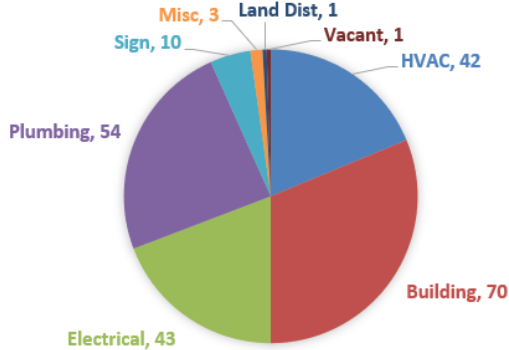

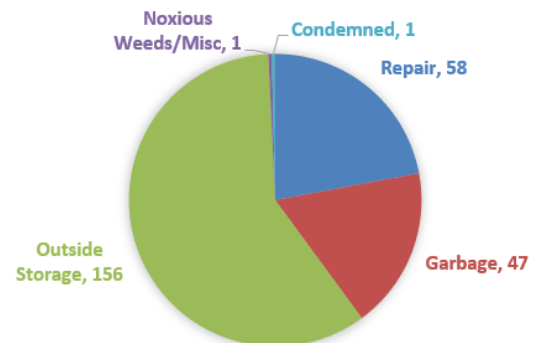
NOVEMBER BUILDING OTCS

Community Risk Education Report

Our Community Risk Educator did three TV interviews and one interview with the La Crosse Tribune, regarding the “**Keep the Wreath Green**” fire prevention campaign that ran from November 27th to January 1st. This is an annual campaign that the LCFD and other area fire departments participate in. Each department displays a large wreath that begins with all green light bulbs. If and when any of the communities suffer from a structure fire, a green light bulb is replaced with a red bulb. This campaign helps raise public awareness and encourages people to make smart fire safety decisions during the holiday season.

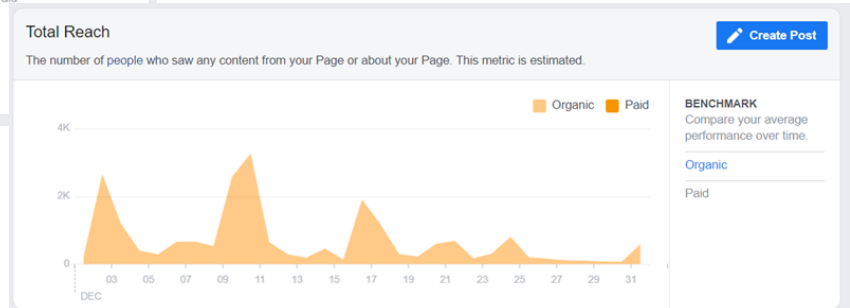
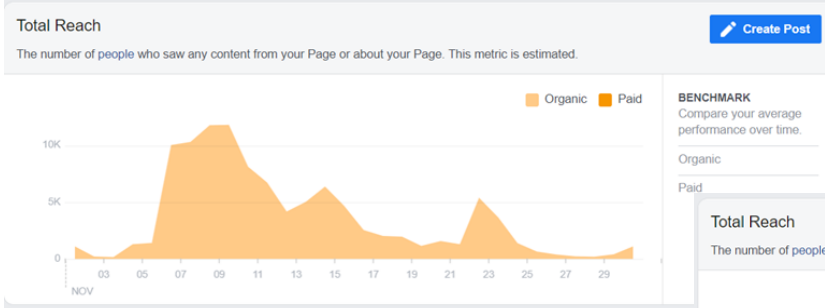


Education/Outreach Programs:

- Taught a WTC fire extinguisher training course for occupational safety students.
- Our first fire and home safety discussion with La Crosse County foster care families. **Very positive discussion and collaboration with community partners.**
- Comprehensive training with all LCFD crews and County Human Services on our **new referral process** for child protective services, adult protective services, and patients who sustain a fall.
- Working with the La Crosse School District on Stop the Bleed training for health educators. The training shows people how to control hemorrhage in trauma situations and we are likening it to life skill; just like CPR.
- Our Community Risk Educator completed the **What Do You Consider Lethal Impact Teen Driving** course and is now cleared to present on the dangers of distracted driving to teenagers. This is in conjunction with the Sheriff’s department and Safe Kids. We are planning on hosting our first course by the end of first quarter.
