### June LCFD Highlights:

- June 6th, LCFD responded to a house fire at 620 Car Street around 4:00pm. Crews arrived within two minutes to find smoke coming from a window and residents attempting to extinguish the fire with a garden hose. Firefighters finished extinguishing the blaze and were able to safely locate and return two of the owner's cats. LCFD had six apparatus and 15 personnel on scene.
- June 9th, Engineer Bryon Stein was selected by the U.S. Navy Blue Angels as a "Key Influencer" after being nominated by the Deke Slayton Airfest for his work helping to educate local school kids during last year's virtual Fire Prevention Week. Bryon flew with the Blue Angels during one of their demonstrations and summed it up as, "It was a once in a lifetime experience I will be forever grateful for. The Blue Angels set the standard of excellence in aviation and I am so proud to have been able to experience flying with them."
- June 9th, LCFD responded to a fire alarm at the City Brewery complex at 4:45am. Upon arrival flames coming through the roof of the brewery's wastewater treatment plant on 2nd Street. Crews determined that flammable vapors form the treatment plant had ignited through the roof. The incident was isolated to a small area and surrounding areas were monitored for gas vapors until safe. LCFD had 15 personnel responded and were assisted by several City Brewery employees. No injuries were reported.
- June 9th, LCFD responded to a building fire at 1117 11th Street South at 6:49pm. Crews arrived to find smoke pushing out of the attic of a duplex. The fire was quickly extinguished and the downstairs occupants were able to evacuate safely. Search crews were able to locate and evacuate a dog from the upstairs unit. LCFD had 15 personnel on scene and assistance was received from LCPD, TSA, HAFD, and Xcel Energy.
- June 10th, LCFD celebrated two classes of firefighter probationary program graduates (2020 & 2021) as well as 2020 promotions with an in-person ceremony.
- June 11th, LCFD responded to building fire at 1717 Taylor Street at 12:15pm. Crews arrived to the duplex with no signs of smoke or fire. After entering the premises, a fire was discovered and quickly contained to the upstairs bathroom. All occupants exited safely and no injuries were reported. LCFD had 16 personnel and were assisted by LCPD, TSA, and Xcel Energy.
- June 28th, LCFD responded to a fire at Hydrite Chemicals, 701 Sumner Street shortly after 3:00pm. Crews arrived within four minutes to large amount of smoke from a fire that started in a trailer next to the chemical bin. All buildings were evacuated, no injuries were reported, and the trailer was reported as a total loss. LCFD had 21 personnel respond to the incident; which is still under investigation. 








