SUMMER SANITARY SEWER USAGE CREDIT: Although there is no credit for additional water used in the summer, Residential utility customers are given consideration for water that may be used for "outside" purposes and do not enter the sanitary sewer system. This includes water used for watering a lawn or garden, or filling temporary swimming pools. "Residential" means customers who live in a property developed on a parcel exclusively for residential purposes with three or fewer residential housing units.

For all residential customers, during the two winter quarters, sewer usage charges are based on actual metered water usage. For the two summer quarters, the sewer usage charges for these customers are billed based on either the actual metered water usage or the average usage during the previous two winter quarters, whichever is lower. The comparison of winter and summer water use and calculation of the quarterly sewer bill is performed automatically by the billing system; customers do not see a "credit" on their bill.

For those Residential properties with separately metered irrigation systems, the sewer usage credit will not apply to the other metered water use.

Late Fee Calculation

Late Payment Charges: If a payment is not received within 20 days of the billing date, a late payment charge of 1% per month will be applied to the unpaid balance, including unpaid late payment charges.
